Wireless service is being provided upon the express understanding and condition that provider is not an insurer or guarantor of the performance of any security system and that it has expressly denied and disclaimed any representations or intent on the part of the provider that the service meet any specific standard for a security system.

It is recognized that radio interference may affect the transmission of a SUBSCRIBER's signal to receiving sites on occasion and that damage could occur to receiving sites, processor, or other related equipment that could temporarily result in the absence of service. Additionally, during routine maintenance to receiving equipment, service may be temporarily interrupted.
